Key Changes Now available from 1st February 2022

Background

In 2021 a consultation document was sent out to all owners with proposed changes to our grant system. Many of these changes were requested in our Owners Wananga and also seen as a way of providing more choice and decision making to the whanau. The changes were supported and are now available to all registered members of Tauhara North No.2 Trust.

Entitlements: What you receive has changed

When you apply for your grants you will find there is a different amount allocated to you depending on whether you are an registered 'owner' or a 'whanau member'.

Individual Health Grant

Each registered owner or whanau member now has there own health grant entitlement. In the past this used to be provided per household. For Vision grants, all applicants will reset to Year 1 entitlement of \$1,100 (contact us to learn more).



Calendar Year

Applying for grants has been made easier! You can now apply for all grants from January to December of each year.

We no longer use 1st July to 30 June for grants.

Education Grants

All education grants will now be paid to the registered parents/guardians of children attending school.



Sports, Arts & Māori Cultural Grant

We have simplified this grant by removing all the representative levels. You now apply for each of these categories, once per calendar year - for the maximum amount: Sports, Arts, Māori Culture. This means you can have a Sports, Arts and a Māori Culture grant in one year.

Scholarships

New compulsory section with a focus on connecting to whanau, whenua and whakapapa.

Additional post-graduate scholarships for students open!



0-5 year olds and students over the age of 15 are required to provide evidence of attending school. This is because the compulsory age to attend school is from 6 to 16 - however, students are eligible to apply for early leaving certificate from age 15.



New Health Grants

There are three (3) new health grants available to registered Tauhara North No.2 Trust whanau:

1.Specialist Grant a.Approved health services i.e. chiropractor, physio b.Not services from GP or nurse 2.Emergency Medical a.High need - cost, urgency 3.Medical Treatment a.Priority for Owners/Kaumatua b.Priority for Hip and knee surgeries
